



## **WEB PRIVACY POLICY**

In compliance with the provisions of the General Data Protection Regulation, Regulation (EU) 2016/679, OPDE Group (hereinafter Opdenenergy), formed by its parent company OPDE Investment Spain S.L. and its subsidiaries, inform the users of its website:

### **Who is responsible for the processing of your data?**

The personal data that you provide shall be incorporated into processes whose joint responsibility is with OPDE INVESTMENT ESPAÑA, S.L. with TIN B-31840135 and registered office at Torre Spínola, Planta 5. Cardenal Marcelo Spínola, 42. 28016 Madrid (Spain), and the entities that are part of the OPDE Group (hereinafter "Opdenenergy").

### **For what purpose are your data collected?**

On the web page or website of Opdenenergy, personal data can be collected in various forms. The data requested in each form are those necessary for the purpose for which they are collected. The purposes of the treatment of data are the following:

- CONTACT FORM: The purpose of data collection in this form is to be able to answer the questions raised and send the requested information to the user through the email or telephone indicated on the form.
- 'WORK WITH US' FORM: The purpose of data collection in this form is for the applicant to take part in personnel selection processes carried out by Opdenenergy.
- ELECTRONIC MAIL: If the user makes contact through an email published on the website that data will be processed in order to respond to the questions raised, as well as send the requested information through the email from which the query is received.

### **How long is your data saved for?**

The data provided by the user shall be kept until the user requests its deletion.

### **Are profiles made with your data and/or are automated decisions made?**

With the data provided no profiles or automated decisions are made.

### **What allows the treatment of your data?**

Data treatment is allowed by the consent given by the user when accepting Opdenenergy's Privacy Policy or by sending an email through the addresses published on the website.



The user must fill in the fields marked with \* on the forms in order to be able to send them; if the indicated fields are not filled in, the user will not be able to send them.

### **Who is your information given to?**

Transfer of data shall only be done in the event of a legal obligation.

### **What third parties provide services on the website?**

The following service providers are involved in the Opdenenergy website:

- "Hosting" provider: The servers where our website is hosted are located in the EU.

### **What rights do you have and how can you exercise them?**

The user may revoke the consents provided at any time.

The user may also be able to submit a claim to the Spanish Data Protection Agency or competent body.

Opdenenergy shall be responsible for implementing all security measures in order to guarantee confidentiality in the storage and processing of personal data, as well as to prevent access by unauthorized third parties.

### **How do social networks work?**
