

WEB COOKIES POLICY

OPDE Group (hereinafter Opdenenergy), formed by its parent company OPDE Investment España S.L. and its subsidiaries, inform the users of its website on the use of their own and third-party cookies to improve their services.

What is a 'Cookie'?

A cookie is a file that is downloaded by the user's computer when accessing certain web pages to store and retrieve information about the browsing that is carried out from that computer. They have a double function, the control and recognition of users, and obtain information about the user's browsing habits.

In general, cookies can be classified in accordance with:

- **The entity that manages them, as:**
 - **Own cookies:** These are those that are sent to the user's terminal equipment from a computer or domain managed by the publisher itself and from which the service requested by the user is provided.
 - **Third-party cookies:** These are those that are sent to the user's terminal equipment from a computer or domain that is not managed by the publisher, but by another entity that processes the data obtained through cookies.

- **The purpose:**
 - **Technical cookies:** These are those created and managed only by Opdenenergy and that allow navigation through this website, as well as the use of its different options and services.
 - **Preference or personalization cookies:** these are those that allow to remember information for the user to access the service with certain characteristics that may differentiate their experience from that of other users.
 - **Analysis cookies:** These are those that, treated by Opdenenergy or by third parties, allow to quantify the number of users and perform the measurement and statistical analysis of the use of this website.
 - **Marketing cookies:** These are those that store information about user behavior obtained through the continuous observation of their browsing habits, which allows to develop a specific profile to show advertising based on it.

- **The period they remain activated:**
 - **Session cookies:** these are those designed to collect and store data while the user accesses a website.
 - **Persistent cookies:** these are those in which the data are still stored in the terminal and can be accessed and processed for a period defined by the person responsible for the cookie, and that can range from a few minutes to several years.

What types of cookies does the Opdenenergy website use?

Cookies used by Opdenenergy’s website are shown below:

No information will be obtained in any case about the user's personal data, ensuring the privacy of the people who browse the website.

External links to social networks:

The Opdenenergy website may have external links to other web pages or internet sites that could treat the information in accordance with other privacy policies (for example, social networks). Under no circumstances shall Opdenenergy be responsible for the use that third parties make of that data if the interested party freely decides to provide them.

In order to improve users’ experience, the Opdenenergy website can enable buttons or links to social networks to allow users to share content they find interesting with their community.

The buttons or links to social networks can also avoid the need to provide further personal data to the Opdenenergy website, since the information already shared with these social networks can be used and Opdenenergy has no access to it.

Social network cookies can be stored in your browser while you browse the Opdenenergy website (for example, when you use a button or link to share content in a social network).

Social networks have their own cookies policies.

Allow, block or delete cookies:

By accessing the Opdenenergy website for the first time, you can accept or refuse the use of all our cookies or if you prefer, you can access the settings and accept cookies according to the type of cookies, except for technical cookies, which are exempt from needing the user's consent. You can change your preferences at any time by accessing our settings panel.

The cookies installed on your computer can be blocked or deleted by setting the browser options installed on your computer.
